Program

1996 saw the enforcement of the Electromagnetic Compatibility (EMC) Directive in Europe. After January 1st, all electrical and electronic products are required to meet a minimum standard of Electromagnetic (EM) emissions and immunity. The USA is not following suit. However, with the trend towards global markets, even products made in the USA are beginning to display the 'CE' mark showing that they comply.

The EMC Directive requires that any electrical device be in harmony with the EM environment where it will be used. This means that while in use it will not inter-

fere with the operation of another device, nor will it unintentionally be affected by the operation of another device. Additional requirements ensure that it remains relatively immune to the EM effects of power disturbances, lightning and Electrostatic Discharges (ESD).

The EMC Directive, now in its fifth year of enforcement, has recently been evaluated under the SLIM initiative to ensure it is working. New requirements under the scope of the EMC Directive are continually taking place, the most significant being the power quality requirement. This requirement limits the harmonic distortion induced back to the source of power by any device consuming more than 75 watts (50 watts shortly).

The presentation will address each of the above aspects, reflecting the status as of February 1st 2000.

Speaker

The presenter is Derek Walton, a 20 year veteran in the EMC field. He is a NARTE Certified EMC engineer, owner of an EMC de-

sign and test company, and an EMC Assessor for the American Association for Laboratory Accreditation (A2LA). He has held EMC positions at British Aerospace, Sundstrand, Honeywell and Invensys, and EMC consulted for companies such as Sun Microsystems, Westell, Contemporary Controls, Rodix, Arachnid and Barber-Colman.
